

Terms & Conditions

The Terms & Conditions of the Eleven Twenty-Eight Ministries are designed to provide you with great service, and to ensure our properties stay in great condition so you'll want to come back again and again!

I FNGTH OF STAY:

The Eleven Twenty-Eight Ministries properties may be reserved for 2 (minimum) to 5 (maximum) day stays throughout the year.

REPEAT GUESTS:

Each guest is limited to two stays per calendar year.

FURNISHINGS:

The Eleven Twenty-Eight Ministries properties all belong to GoodFeather Outreach, Inc. The furnishings will reflect our personal taste. You will be provided:

- Bed Linens
- Bath Towels (Bring your own beach towels!)
- Dishwashing soaps, trash bags and a startup supply of paper products and bath soaps.
- Florida Location-Kitchen has silverware, dishes, pots & pans, small appliances including toaster, blender and Keurig coffee maker (don't forget to put coffee on your grocery list).

CONFIRMATION:

A confirmation listing arrival and departure dates, and property information will be emailed to you upon acceptance of your reservation request. Please contact us immediately by phone (423-438-3241 ext. 9100) or email us (reservations@goodfeather.org) if any corrections are necessary; otherwise, it will be assumed correct.

CANCELLATIONS & CHANGES:

It is never fun to have to change your plans but if you have to, please give us advance notice.

MANAGEMENT:

- WE RESERVE THE RIGHT to refuse or to discontinue occupancy if, in our judgment, your occupancy is detrimental to the property. Property may not be used for any unlawful purpose.
- We reserve the right to enter the premises at any time for the purpose of inspection or repair.
- By staying at this property, you are assuming all risk of and liability for any damage done to
 person or property, agents, employees or visitors occasioned by the present or future condition
 of the premises both latent and manifest. Neither Good Feather Outreach, Inc nor Eleven
 Twenty-Eight Ministries will be responsible for accidents or injury to guest or loss of money or
 valuables of any kind.

OCCUPANCY RESTRICTIONS:

Violations of occupancy restrictions are grounds for IMMEDIATE EVICTION.



- The listed "LIMIT" number (4) indicates the maximum number of occupants including children allowed in a property at any one time unless prior approval has been granted in writing.
- WE RESERVE THE RIGHT to require lower occupancy in the case of chaperoned and other groups.
- Atmosphere conducive to quiet enjoyment of those in surrounding properties must be maintained at all times.
- All rules and regulations at each property must be strictly observed.
- Minimum age to reserve this property is 25. NO PARTIES ALLOWED

PARKING:

There is NO on-street parking at the Eleven Twenty-Eight, so please plan accordingly. Our properties have room for 3 cars. (you'll have to leave one at home if you are bringing a boat or jet ski trailer).

PFTS:

We love pets, but NO PETS are allowed on these properties. A pet, or any evidence of a pet found on the premises, is cause for eviction and forfeiture of your stay. A cleaning fee of \$250 will be charged if evidence of a pet is found after your departure.

GRILLS:

It is a violation of local fire codes to grill on a deck or porch. Don't do it.

MAINTENANCE:

It is important to us that the property be maintained in good repair. Maintenance providers may access the property for purposes of repairing previously reported issues, or for routine items such as lawn maintenance. We strive to be as unobtrusive as possible while performing these tasks and appreciate your patience—it is important to you and to us that the property be well maintained.

- Please let us know as soon as possible if a maintenance issue arises. Just
 as might occur at your own well-maintained home, mechanical failures and other breakdowns
 could occur. Please call us at 423-438-3241 ext. 9100—we will make every effort to correct the
 situation as quickly as possible.
- Working condition of air conditioners, cable, phones, Internet service, TVs, DVDs, appliances, etc. are NOT guaranteed. These amenities are extras provided for you. We will make every effort to correct the situation during your stay.

DAMAGF:

Please report any damage or breakage when it occurs so we can fix or replace items as soon as possible.

- Some things break or need repair or replacement due to normal wear and tear or factors out of your control. Please let us know about those items so we can take care of them. We want to keep things in good condition.
- We understand accidents happen. We ask that you let us know about them. Unreported new
 damages found upon your departure will be billed and full payment for repairs will be collected
 via credit card.



- Burns of any kind (furniture including deck furniture, carpets, counters, etc.) will be considered fully your responsibility.
- Missing items are considered damage. Please do feel free to leave a book you have finished to
 add to our library. Please leave our games, decorations, pillows and bed linens. Removing
 makeup with towels, washcloths, etc. may cause stains that cannot be removed. Just like at
 home, we do not have extra pillowcases that match our sheet sets if one is taken—we have to
 purchase a new set.
- Any damages to the Eleven Twenty-Eight Ministries properties during your stay will be repaired and you will be invoiced for the repairs.

CHECK-IN:

- Following receipt of the confirmation email, we will provide key information for check-in. Your access instructions will be emailed.
- Check-in begins at 4:00 p.m. EST.
- We make every effort for the property to be ready for your arrival at that time; however, much
 of that depends on the courtesy of our guests and the condition in which the property is
 left. Our housekeeping standards may require extra cleaning time which may delay checkin. We ask for your patience in the unfortunate event this happens on your check-in date. And
 we ask for your help in ensuring it does not happen to the guests who arrive after you!
- Early Check-In is not available during busy seasons (spring and summer). We encourage you to
 enjoy our public lakes and local shops, restaurants and attractions if you arrive early. Early
 check-in MAY be available in other seasons or if the property is empty the week before your
 arrival. Please ask by email several days in advance of your arrival day.

CHFCK-OUT:

- Check-out time is 11:00 a.m. EST, AT THE LATEST! If you are leaving significantly earlier, we
 would love a call the night before to the number on your check-out instructions. Our
 housekeepers really appreciate having a little extra time to do their work.
- Late check-out is never available on weekly stays or in peak season. Outside of peak season late check-out MAY be available. Please request this in writing several days before check-out. We will accommodate your request if at all possible.

SMOKING OR ALCOHOL USE

No smoking or alcohol is allowed on the property. Evidence of smoking or alcohol use on the premises will incur a charge of \$500, plus any additional damages caused by smoke or burns. Please treat our home as you would like for us to treat yours.

DEPARTURE RESPONSIBILITIES

See instructions posted at the property for specifics but here are the general details.

• Leave property reasonably clean and in reasonable order. Please remember that this is a ministry. Please treat our home as you would like us to treat yours. All furniture, decorative items, bedding, dishes, etc. should be where it was upon your arrival. If you love our linens,



games or decorations, we would be happy to help you find similar items but please do not remove ours!

- Leave kitchen items (dishes, cookware, etc.) cleaned and returned to their proper place.
- Dispose of all trash in proper outside containers.
- Lock all windows and doors.
- Please leave all used beds unmade.

We have made every effort to ensure that all information printed here is accurate but cannot be held responsible for errors in printing or changes made in furnishings and appliances. The appearance and amenities of the property may have changed from the photographs as we consistently update the property. Any exception to the above-mentioned policies must be approved in writing and in advance by Eleven Twenty-Eight Ministries. management.
